Saturday and Sunday, walk through and briefing will begin at **7:45 AM**, Judging will begin at **8:00 AM**

- Running order is determined alphabetically. Handlers with more than one dog in a class will be separated if possible.
- All Exhibitors for a given class should be present at ringside at least one-half hour prior to the start of the scheduled classes for walk through and briefing.
- Any dog and handler not present when called will be ineligible to run.
- All conflicts will be handled by the Gate Stewards.

## **CHECK-IN**

**\*\*\*IF you include a readable photocopy of your dog's NADAC card (for max height dogs) OR Permanent Jump Height Card, with your entry; you **will** be automatically checked in.**  
Dogs who require measuring must check in and be measured. **Measuring is not optional, if a dog is not measured, it is not eligible to run. So don't miss your check-in/measure-in time. SKILLED DOGS DO NOT NEED TO BE MEASURED.**

**Check-in will be at 3:00 – 3:30 on Friday and Check-in and measuring will be at 7:00 - 7:30 am on Saturday and Sunday.**

## **REFUNDS**

There will be no refunds for entries withdrawn after the closing date or in the event a dog and/or handler are dismissed from competition, regardless of the reason for such dismissal.

A withdrawal from the competition after the closing date due to a bitch coming into season after the closing date will be eligible for a refund up to 75% of the total entry fee paid.

No entry fee refunded if the trial cannot open or completed by reasons of riots, civil disturbances, fire an act of God, public emergency and act of public enemy, or any other cause beyond the control of the organizing committee.

## **MOVE-UPS**

Move-ups, changes, or corrections will accept in writing only (or e-mail to [jdoepke@cox.net](mailto:jdoepke@cox.net) through July 5<sup>th</sup> at 6:00 PM. **No changes/corrections will be accepted after this date.** This includes any changes that need to be made because of incorrect entry on trial secretary's part. Please read your confirmations carefully prior to July 5<sup>th</sup>. There will be move-ups from Saturday July 10<sup>th</sup> to Sunday July 11<sup>th</sup>. You must sign the move-up book (on site) by 15 minutes after the last run on Saturday to be moved up for Sunday's runs.

**IMPORTANT:** Please check your dog's NADAC registration number on your trial confirmation as soon as you receive it; also, please check the copy of the results posted at the trial. You should report any errors to the Trial Secretary immediately.

NADAC records trial results as they are submitted by the host clubs/groups. The individual trial results submitted by the club are uploaded to the files section of the [NADACAgility@yahoogroups.com](mailto:NADACAgility@yahoogroups.com) list within two weeks after the NADAC office receives them from the club. The trial results will remain on the list for at least thirty (30) days. Please accept the responsibility to review those results, and check that your registration number and qualifying points, as reported by the club, are correct. You can join the NADAC Agility list ([www.NADACAgility@yahoogroups.com](http://www.NADACAgility@yahoogroups.com)) and set your settings to "no mail". You will be able to view trial results and check for any possible discrepancies, without receiving list mail. If you find an error in the reporting of your dog's qualifying points or registration number, please contact the host club. The host club is responsible for correcting any errors and informing NADAC.

**Levels.** Points earned at a higher level of a class, prior to the completion of the lower level title, will no longer be banked by NADAC for future use. If a dog earns points in a level of a class that they are not eligible to title in, those points will not be added to the dog's records.

### **NOTICE TO COMPETITORS**

This trial will be held under the current rules and regulations of NADAC with Leaps N Bounds Dog Agility as the sponsoring club. NADAC rules will prevail. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations, and agree to abide by all the rules in effect at the time of this trial. The trial committee has the right to refuse entry to anyone including anyone not in good standing with NADAC

**DOGS MUST BE REGISTERED AND HAVE A VALID REGISTRATION NUMBER BEFORE ENTRIES WILL BE ACCEPTED.**

### **IMPORTANT INFORMATION**

**Exhibitors through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations and agree to abide by all rules in effect at the time of the trial.**

- Please double-check your entry form, especially your NADAC number, to ensure it is filled out completely and correctly. Entry may be returned if missing information is critical to entry. Also, double check the results at the trial to make sure that your NADAC number and scores are posted correctly.
- **IMPORTANT!!! ONLY electronic confirmations will be sent out. They will go to all entrants who include their email addresses with their entry. If you included an email address, your confirmation will be sent as an attachment (PDF) in an email. It is your responsibility to make sure [jdoepke@cox.net](mailto:jdoepke@cox.net) is allowed by your spam blocker or to change options that strip attachment from emails.**
- Confirmation of entry will be sent to the address provided on the entry form (e-mail or snail mail) after closing date. **If an exhibitor has not received a copy of the confirmation within 7 days of the closing date, contact the Trial Secretary.**
- Please review this confirmation carefully as there are ONLY Saturday to Sunday MOVE-UPS at this trial. If there are any changes that need to be made because of incorrect entry on trial secretary's part, you must notify Trial Secretary by **July 5<sup>th</sup>**. Corrections will not be made the day of the show.

- **Checks not honored by the bank DOES NOT constitute a valid entry fee. There will be a \$35 service charge for bank returned checks.**
- All dogs must be on leash when not competing in the ring.
- No smoking is permitted on the show site.
- Ribbons will be awarded to first through fourth places in all jump heights in all classes. Ribbons awarded for those finishing a title and qualifying ribbons awarded for those achieving a qualifying score. Chances is a pass/fail class therefore no placement ribbons will be awarded for these classes.
- Leaps N Bounds Dog Agility will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result is by accident or any other cause. It is distinctly understood that every dog at this event is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee be asked to leave the show site. In such case, no refund of fees paid will be made.

**We reserve the right to refuse entries**

**PROFICIENT / SKILLED CATEGORIES:**

Each class will be split into two categories, Proficient and Skilled.

Skilled Category, dogs MUST jump 4" lower than indicated by the current jump height table. (No dog can jump less than 4".) In all classes, except Regular, a qualifying round must be clean. Only in Regular is a five fault acceptable for a 5 point Q.

Proficient category a qualifying round must be clean; no courses faults, no time faults.

**NON-JUMPING CLASSES – VETERAN HANDLER:**

Handlers who are 60 years or older, or who have a disability that restricts mobility, may choose to enter the non-jumping classes as a Veteran Handler and receive 10% more standard course time. This option is for Veteran/Disabled handlers in the non-jumping classes only.

The Veteran/Disabled Handler division is designed for handlers who, due to age or impairment, are mobility limited and need extra time to guide their canine partners through an agility course.

When entering as a Veteran/Disabled Handler, you must enter all dogs in all classes for the entire trial in this Division and must jump 4" lower than your Proficient, Standard Division jump height requires. In the non-jumping classes, dogs will be scored and placed with their Standard Division jump height.

**Jump Heights:**

Dogs entered in the Proficient Category must jump at the minimum jump height specified by the following table. Dogs entering the Skilled Category **must** jump one jump height lower than the heights listed in the table.

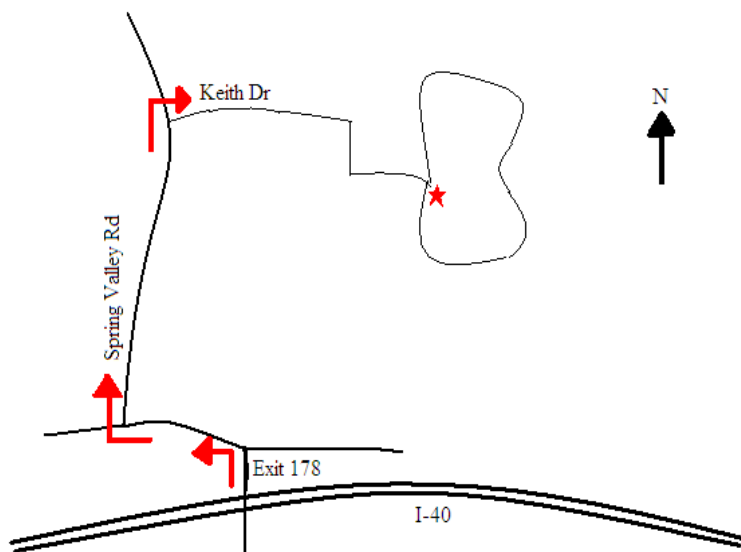
As the table shows, there are five Standard Division-Proficient jump heights: 8", 12", 16", 20", 20+. There are four Standard Division-Skilled jump heights: 4", 8", 12", and 16". There are four jump heights for the Veterans and Junior Handler divisions: 4", 8", 12", and 16".

Veterans and Junior Handler dogs must jump their valid jump height and may not jump higher; thus, a Vets or JH dog may not jump higher than 16" in the Proficient category and no higher than 12" in the Skilled category.

There is no 4" Standard Division jump height in Proficient; the 4" Proficient height is for veteran dogs/handlers, disabled handlers, and junior handlers only. In the Skilled category, 8" dogs may jump 4" as their standard jump height. No dog may jump lower than 4".

**AGREEMENT**

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

1. As used here "NADAC" means the North American Dog Agility Council, Inc., its members, officers, directors, employees, show chairs, show committees and agents.
2. Exhibitor/owner agrees to abide by the rules and regulations of NADAC and any other rules and regulations appearing in the premium for this event.
3. Exhibitor/owner certifies that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
4. Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the floors, stairways, halls, lighting, security measures or lack of, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.
5. Exhibitor/owner release NADAC, (including NADAC officers, directors, employees, and members), Leaps N Bounds Dog Agility (including its officers, agents, and employees), and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assume sole responsibility for and agree to indemnify and save aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury, or death may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.
6. Exhibitor understands there is a returned check fee of \$35.
